## From CTI's Policy and Procedures:

## ARTICLE III – MEMBERSHIP

Section 1: Membership is open to all interested persons without regard to age, race, creed, handicap status, religion, national origin, color, or sex may become a member in City Theatre, Inc. upon payment of the required membership dues. A person may become a member by paying specified dues. The Membership Chair, the Vice President of Operations, or the Treasurer can personally accept membership payments or payments can be made by mail or dropped off at Sermon Center to the attention of CTI Treasurer.

**Section 2:** There shall be no differences among the classes of membership regarding rights, privileges, activities, or duties of membership.

Section 3: Membership dues shall be determined by the Membership Committee and be published in CTI Policies and Procedures. Each person who tenders payment of the dues so established shall be entitled to full membership in City Theatre, Inc. for the fiscal year of the organization in which the payment is made. Membership dues are due and payable by July 1 of each calendar year, but membership for the current fiscal year may be accepted at any time during such year.

**Section 4:** Members whose dues are paid and current shall be entitled to one vote on all matters acted upon by the general membership at scheduled or specially called meetings in person or by proxy. Members shall be eligible to participate in all activities, to hold office, and to receive all other rights and benefits of membership.
